It may true that present concept of the country can be imagined by the ruling partyas ideal country but in true sense it has not been visualized in any part of the globe. The paper is written in the present scenario when COVID-19 spreads through out the globe. All peoples immediately need vaccines to save his/her life without further delay. It isnow the primary task of each Government in the world to give the vaccine in a priority manner since the availability of vaccine is not enough specially in the high population countries. The view of authors is that there is no problem of giving vaccine to the peoples if each country will be an ideal country. So these two are related and hence the title highlights them in a true sense.

The purpose of the manuscript is not to hurt anyone in the globe but the concepts are proposed as vision of authors. Also the proposed system is a new one and may be good for the people in the world. The entire concept is to run the country by proper, sincere and honest experts instead of running the country by the selected peoples with an interest for their parties.

I. EXISTING SYSTEMFOR RUNNING THE COUNTRY

In the present system there is a ruling party and one or more opposition party(s). Obviously peoples gave more supports to the ruling parties based on their performance or their indirect pressure on peoples. The study is made for all countries in the globe for projecting the vision of Ideal Country. It is true that the present system in countries are tested over a long period of time but new approach will be a better one if it is implemented over a period for testing purpose. In the existing system the ruling party tries to implement many good things for peoples but opposition parties stop these implementations due their own interest or they think that these decisions are not help to increase support of peoples for the party. Some of the decisions taken by the ruling party are good but the process of implementation is biased. The opposition parties took these as wrong decisions since it does not help them to gain anything. Consider an example of city. Actually city is a sub-graph of country in terms of graph. Now consider a family of a cityin a country. Normally in each family there is a man who is actually controlling the family. He/she is called Head of the family. If there is more than one is supposed to control the family, then it will create a mesh provided his/her views are wrong. It does not mean that opinions from more than one family member is bad. For the best of the family more opinions are fruitful in most of the cases but not in all cases. Any changed opinion has to be scrutinized properly. It is like a country where Head of the country performs his/her duties for the betterment of peoples in the country. The head of the family will do the same thing with less members. It is true that there is also diversification of opinions and may

not be an ideal family. Less diversified honest views may create an ideal family. In country the oppositions are required for rectification of wrong decision by the ruling party and not for creating delayed betterment for peoples as a whole.

All the parties in the globe claimed that they are giving better democratic rights to the people. It is true in some cases but majorities did not want to give proper rights to the people. Mathematically it can be proved that it can not be done practically. It is now explained. Suppose a man is nominating by the party for contesting the coming election. It is not always considered whether he /she is a fit candidate or not. It happened normally that the powerful man/woman in the party proposes the name. So the candidate needs to make happy the proposer. Now consider the another practical situation. For campaigning he/she needs to spend money to make him/her closes to the peoples who are exercise their opinions to the person. The candidate has to ask well wishers to donate money for the campaigning purpose. It is very difficult to believe that well wishers will give money without any commitment from the person. This is not true in all cases but most cases it is true. In family the head of the family will always have a better look to the member who helps family with more for reasons or without reasons. The candidate, if elected, will try to fulfil the dream of well wishers as far as possible with a hope that they will help him/her for the next election. So money is necessary but can not be the deciding factor. This is true for most of the candidates. So in reality some peoples have more priority than others in the country. So the creation of closest groups for all candidates are essential. So the right enjoyed by them is not same in comparisons to others. They did not support the concept of Ideal Country. The head of the party is currently selected by the elected members in a close door meeting. If the selection is made unanimously, then it is declared in front of general peoples. In most of the cases rift may be possible but it can be managed by giving some promise to one or more persons. Powers can be in other forms also either directly and indirectly. For vision of Ideal Country, it is required to consider this seriously in case of selecting Experts.

There are large number of countries in the globe. Populations are also varied. High population countries are not large in the globe. So it is not unthinkable to make an Ideal Country since it consists of building cities by Experts only. So in case of more population it is just more cities in the country and more Experts are required. It is feasible.

Division amongst peoples of the country is created for their own interest and it is not the good for peoples. In country there are different powerful wings where peoples can enjoy more powers than others. In the present scenario the peoplesare placed in the prestigious positions based on the connections not on the quality. It is true for most of the cases. So the concept of Expert is needed as per the definition of the Expert specified below. It is true that an Expert can not only be knowledgeable but also honest and sincere. In an Ideal Country the proper definition of expert is strictly followed and selection is done accordingly. The selection procedure of an Expert will be specified in the subsequent paragraph.

Hence structure of a country is assumedhere for explanation of the concept of Ideal Country which varies widely from the present concept of a country. In the present system a country consists of a number of states/provinces and one or more cities are in it. Each country has a concept of top down hierarchy where the top of the country is named as center or other. It is the top of the hierarchy i.e. root. It does not any matter if these two parties are different. All the parties are elected by the people and then Head of the party decides the way of functioning the state with the help of elected members of

the party. The same is true for the Center. Members actually serve the necessity and development of the peoples. The concept of Expert is not at all considered. For example, a member will look after the progress of industries or formation of new industry without any knowledge of any background of the industry. The same thing also happens to other domainsalso. There is not always possible to get actual expert to the right field and this is always true that expert in different field may not good to run the field where he/she has no expertise. This can not be true for all but there is always exception. In long run it may delay the proper development of the people.

It is quite common that available facilities are not properly checked and used by the ruling party of the state/center. Since the party always projectstheoretically democratic right to the people and try to make a demarcation based on the economic condition of people. In the present structure it is obvious that high income group will get the highest facilities since they have all the requisite to do so. Their family members will get the best education in a renowned institution. Merit is not the factor. The ruling party of the country marked a grading system of the institutions in the country for fulfilling their purpose. It is not possible to enrich other institutions so that the grading is not necessary.

The idea of the manuscript is not to allowall peoples to be educated in eminent institutions. In practice the state/center does not have the statistical data of students who needs education in the coming future. It is also required to know that percentage of students will go for higher studies. It may true that it is not the duty of the state/center. It is difficult to consider each facility individually but the objectives will require for all cases equally. At the same time, it is not the objectives of the parties that the state/center is self dependent. If the state has a number of cities, then it is really unmanageable. So the Ideal Country is based on a graph with less subgraph as per as possible. It is not the idea of the paper that the present system is bad in all respect but the aim is to reoriented some parts/ whole part of the presentsystem in such a manner so that the actual benefits can reach to the peoples. It is confirmed that the paper does not present any political concept. It presents a study over periods considering different aspects of a country to make it as Ideal as possible. The concept will be presented in the next section and it may difficult to convince others since it is not yet to be implemented and tested. Authors present this concept with a hope that peoples did not think any motivation beside this article. The entire concepts are the view of authors.

In the paper it is assumed that country is a graph and all cities under it are sub-graph. Here the concept is shown only for a country. The same concept is applied for other countries also. Initial phase of the concept is presented here and the entire mapping for other phases will be presented if and only if it is accepted as a primary step. Some assumptions are made and will be given in the next section. This concept if at all accepted in future by the peoples of the globe then it is the request by the authors to the readers for suggestions. This work does not propose for a particular country but the concept is applicable to other countries also.

Vision of Ideal Country

Ideal country is an imagination of authors. It is not biased in any respect while framing of the concept initiated. The fundamental idea of Ideal Country is based on the use of true Experts as per the definition of dictionary. A real expert means that he is knowledgeable in the particular field(s) and has true intention to work assigned to him/her by the peoples of the country. An Expert has the following qualities:

It was mentioned earlier that a country has a number of cities. In this paper the approach will consider one city as an example and it is assumed that the same structure is applicable to other cities of countries also. The main objective is to make each city self sustainable in all respect. Author thinks that the requirements of Ideal Country for the peoples in a country are not too much so that it can not be manageable. In the present system it can be possible to make peoples self sustainable but certain constrains are unavoidable. Let's consider the needs of peoples to make life comfortable and enjoyable. In the proposed approach it is assumed that all peoples enjoy the same facilities as other peoples. Now it is time to specify the facilities that are required for the peoples. These are:

- 1. Family welfare
- 2. Education

- 3. Food
- 4. Amenities for enjoy
- 5. Free legal aids
- 6. Free entertainments
- 7. Bonding with other peoples
- 8. Free transport facility
- 9. Recreation without investment

The main aim of the paper is that Experts have been running the country. It is true that it is difficult to get experts as per the qualities specified above for an expert. The selection of experts is difficult but in a country a number of experts in the related area are available but the proper selection is not made due to biasness or some other unknown reasons.

In a country there are genuine experts who are unable to do such complicated and hard works due to age or other reasons. Initially these peoples are selected by peoples of the country for choosing real experts who will run the country. These experts shall be selected based on the expertize in the related fields based on the qualities as specified earlier.

The new concept of a country can not be built up immediately. Before it can be implemented phase wise it takes time for initial phase of selection of experts. Also the new process needs to approve by the peoples of the country. The new concept or part of new concept does not same to any existing process truly in the present system of any country.

The proposed system initially needs finance to start the concept. For this reason, a corpus fund is created and this is used by selected Experts of all countries to build the system initially. The idea of the new concept is entirely based on experts in practice not they are theoretically experts. All the experts in the country are assigned to build up the city where peoples of the city shall have democratic right as well as they enjoy equal rights for using foods and other amenities. These are supplied by the Experts who are given charge to run the city.

So the first step of an ideal country is the selection of experts for running cities in the country. Next these experts will find out statistically the information such as total populations in the country, number of families and details of family information such as members age, number of males and females, their qualifications, number of children (need education) and many more as desired by the experts. This information is definitely collected using office in each city. These will be help for the peoples in the city as full time engagement for the city.

Suppose experts selected that the maximum populations in a country is P and number of families in a city are F. For equal division of families in a city it is required to find out the number of cities in the country. So it is calculated as P/F and the division indicates number of cities, say C. For ease of understanding the entire details of a city is projected and it is assumed all the cities will have the same structure as specified for the particular city.

Another important part needs to be considered while dividing the cities in country. Try to make each city self dependent in respect of agriculture, free spaces, etc. The sincerity and honesty of peoples in the city are the essential part of consideration related to frame a city. It is also required that each family of the city understood the concept and like the concept from their heart. This concept helps all peoples regarding engagement, food, health service, education and legal aids, if necessary, within the city as well as in other cities. There is no division amongst peoples in the country and their social life will be honestly maintained by the experts of the city. In the city peoples did not spend money for running their daily routines but only think is to do work as per their capability in the field where they have knowledge and interest. Authors believed that people can do any type of work if they have interest in it. Let us briefly describe the way the concept will work. Authors believes that the concept can be improved after implementation it and a through discussion at the end of each month may help to improve the concept.

From the statistics of the family belongs to the city, experts can find out the proper education needed for each family. It helps to think about the formation of schools, colleges and universities in the city. Each of these are same standards and has requisite seats for admission of students from each family. All the teachers have the interest in teaching for students and do the best effort so that students are enjoying the learning process. They also know that their expertise will be used in future for the city. It is the opinion of the authors that schools, colleges and universities shall be optimized so there is no need of choice of particular since experts honestly selected this based on the distance from their house.

It may be long history if the entire concepts are specified in sentences. So to make the idea of Ideal Country is given in point wise then readers can understand the concept easily. The concept of an Ideal Country is presented below in a point wise:

1. First consider the globe or entire world

- 2. World is composed of countries
- 3. Each country has a number of cities
- 4. Each city has a number of families
- 5. Each family has a number of members
- 6. Each city is demarcated by Experts
- 7. Find out the true Experts who proves their expertise in their fields but unable to do the work due to health or other reasons
- 8. These experts will select another set of Experts having expertize in their fields for cities
- 9. These Experts will actually make each city self independent
- 10. An office will be created for these Experts for regular works for the city
- 11. The efficient peoples are selected from city for working in the office for various works and it creates an employment environment
- 12. Each Expert is regularly updated the actual work is done and to be done in near future
- 13. For education, peoples work under Expert will first statistically collect each family data regarding details such as number of family members need school education as will as for higher education in the city
- 14. These will help for creation of schools, colleges and universities in the city. Here it is assumed that all are academically same standard. It is also assumed that members of the family shall not move too far for attending schools, colleges and universities
- 15. The process helps to recruit efficient teachers from the city only. If required, training of those selected teachers are made
- 16. This will create employments for peoples in the city
- 17. For transport, it is first determined the number of vehicles are needed based on the calculation of total families in the city
- 18. It also calculated the number of manufacturing cars are there in the city and the number of petrol pumps are needed
- 19. It is assumed that peoples do not have money and they will enjoy all the facilities as provided by Experts
- 20. So Experts are the key persons and maintained all the facilities to the peoples
- 21. Similarly, maintenance facilities are required in the city
- 22. All the above creates employments and since the population of city is not large so it is manageable by Experts
- 23. The vehicles needed by the family are to be informed to the office of the Experts at least one day before the vehicle is needed
- 24. The office of the Experts has different Sections for giving services to the families in the city
- 25. For agriculture Experts are selected first the land (s) and engaged peoples who are interested in agriculture
- 26. Foods for the families are generated from the cultivation of lands for preparing foods for the city.
- 27. The Agriculture Experts are first calculated the lands along with the type of the foods are required for each family. It may vary city to city and country to country
- 28. So a large employment for city are generated
- 29. Health Experts will calculate the number of hospitals are needed for the city
- 30. For unforeseen situations like COVID-19 there are some hospitals are created for overcome these situations
- 31. This type of disease needs vaccines for overcoming the natural disaster and the process and priority of vaccines are determined by the Medical Experts

Here some facilities are pointed out but others can be done similarly. In this paper authors know that imagination is one thing and implementation is totally different. But it is true that first is required imagination of any work other wise problems can not be understood. Here a new view is to be given and it is true that instead of managing the entire country Experts can manage city efficiently.

II. CONCLUSIONS

It is the imaginative views of authors. Authors do not want specify that the present system is based on thinking of many eminent persons. Here each country in the globe is divided into cities. The concepts of Experts are giving priorities. Since money handling is assumed minimum so proper developments for the peoples are done efficiently. The concept of delay in solving problem is reduced since actual Experts are handling the problem. It is true that they are also human being but in a country there are Experts who have the requisite qualities. Authors want to get views from the readers and it is the actual aim of the paper.
